- 4. Year 1: December 2020—digital delivery service of 1200 endowment and donor reports (includes endowment reports, annual donor giving summaries, unit reports, and an annual "Year in Review" report)
- **5.** Year 2: November 2021—digital delivery service in addition to

The endowment fund consists of two parts: spendable, representing the dollars available for spending to support the fund's designated purpose, and endowment, representing the fair market value invested through the Foundation's long term pool.

### New contributions

Gifts and piedge payments during fiscal year 2020.

### Investment earnings

The total amount earned by this fund during fiscal year 2020.

1% annual administrative fee. For new gifts, may include up to 5% fee which is transferred directly to the

### Administrative fee reinvestment

Due to significant cost savings, the Foundation Board of Trustees voted to return a total of \$1,095,000 back to Spending for designated purpose all endowed funds on a pro-rata basis as of June 30,

May include revenues other than gifts, expenses associated with receiving gifts, and misc. expenses.

Unspent cash returned to endowment.

Cash made available for spending Dollars available for the University to spend on the donor designated purpose. This amount is calculated each year according to the Board approved spending policy (formula) which incorporates a 4% stated rate

### and fair market values on December 31.

The dollars spent during fiscal year 2020 in accordance with this fund's designated purpose.
